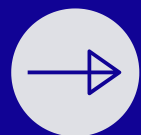

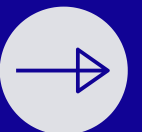




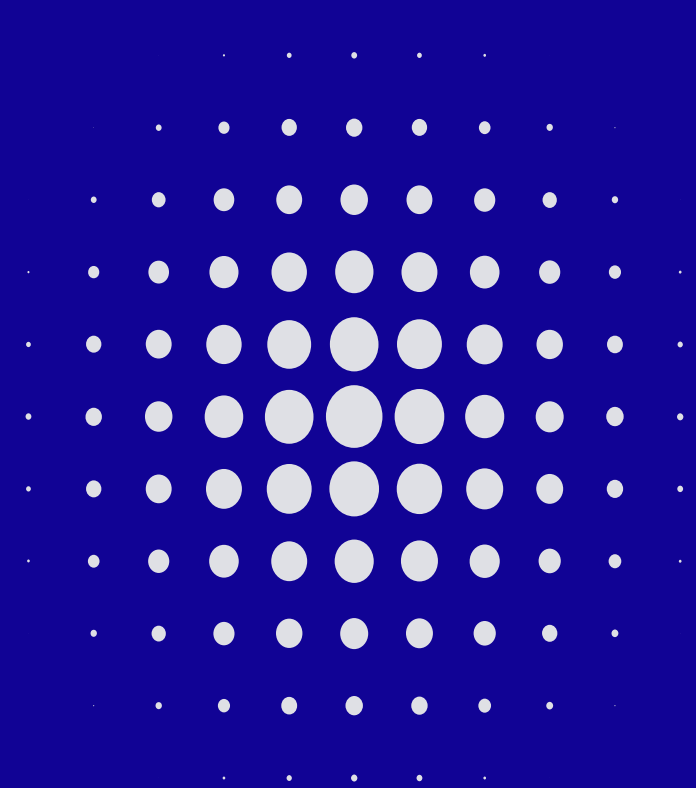
Payroll is Broken for SMBs

Small businesses struggle with slow, manual payroll and risky compliance gaps that drain time and cash.

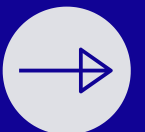
- 1** SMBs spend over 20 hours per month on payroll administration, diverting focus from core business activities.

- CAGR ~18

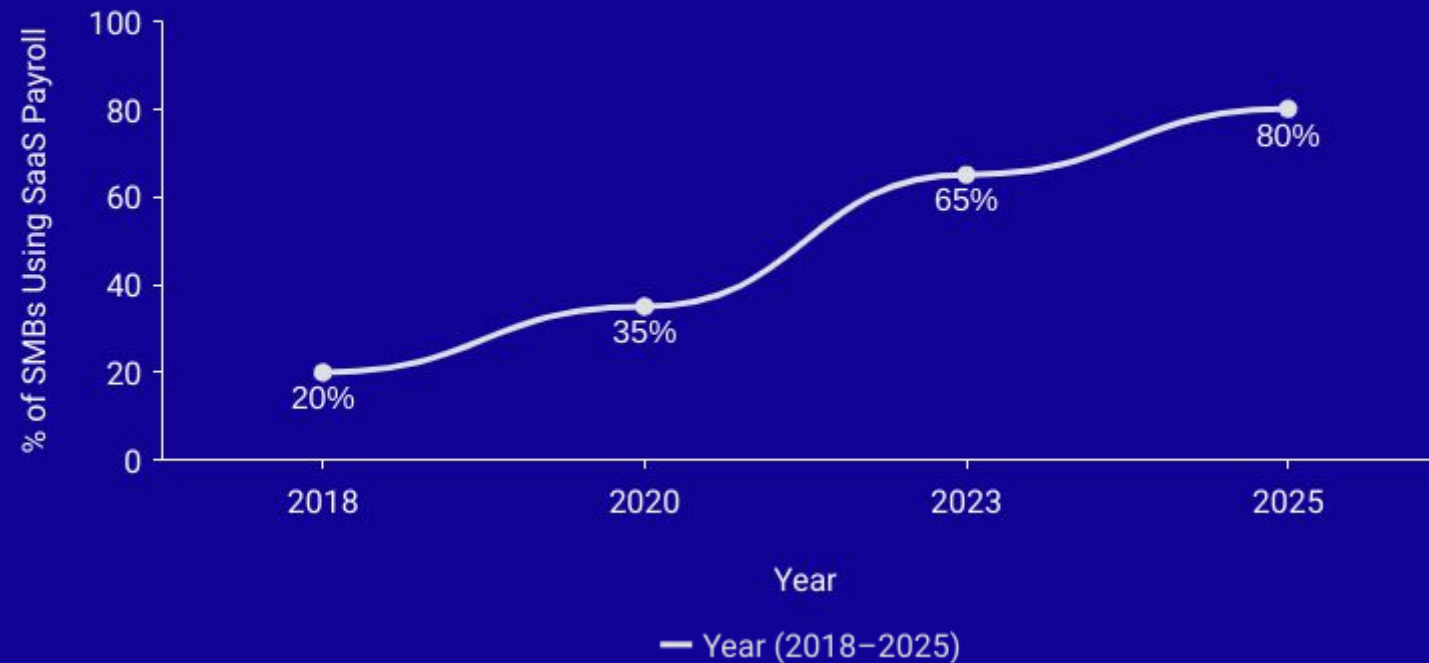

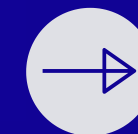
SMBs are Rapidly Moving to SaaS

Cloud payroll adoption is accelerating as SMBs replace manual and legacy systems with scalable SaaS solutions.

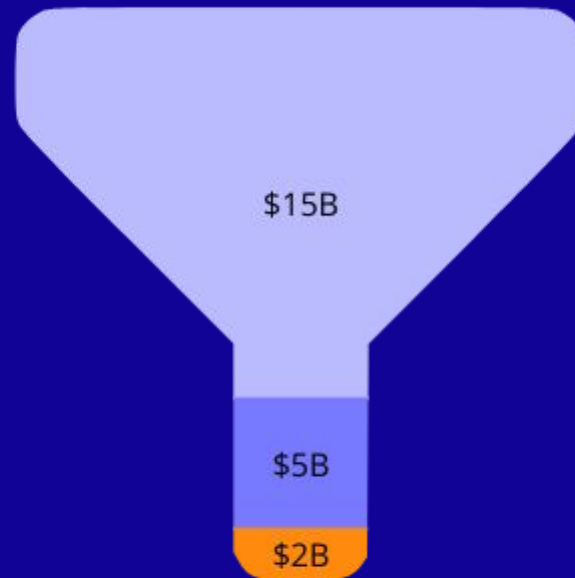

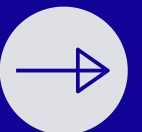

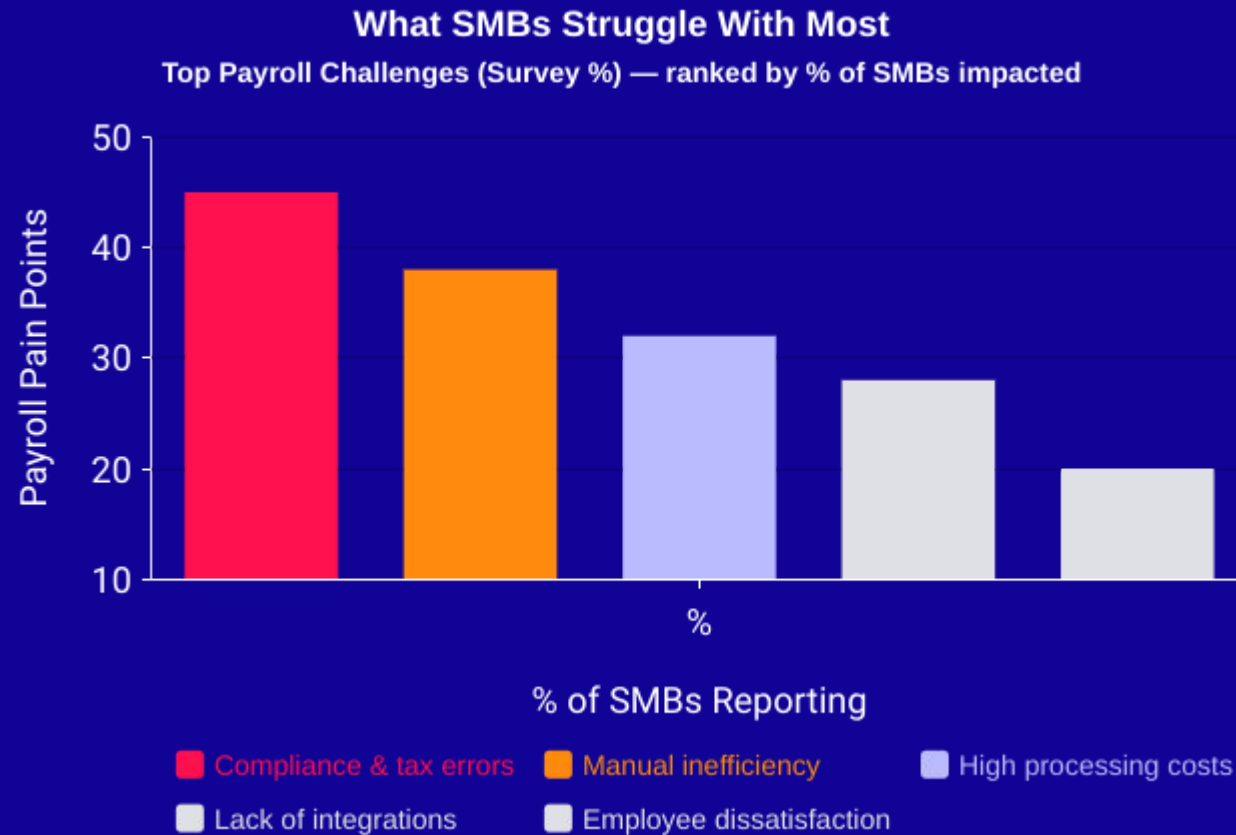

Rapid Growth with Expanding Margins

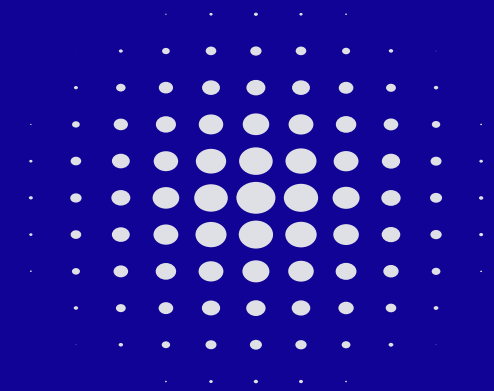


- Revenue CAGR 120% YoY (2021–2024)

- 95%+ retention ensures predictable recurring revenue

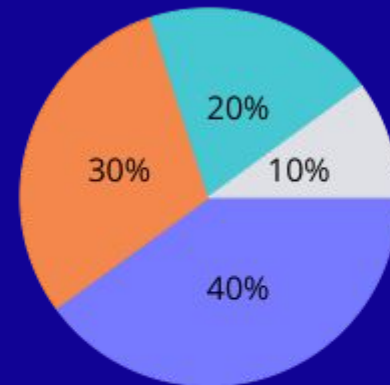

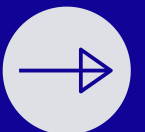
